

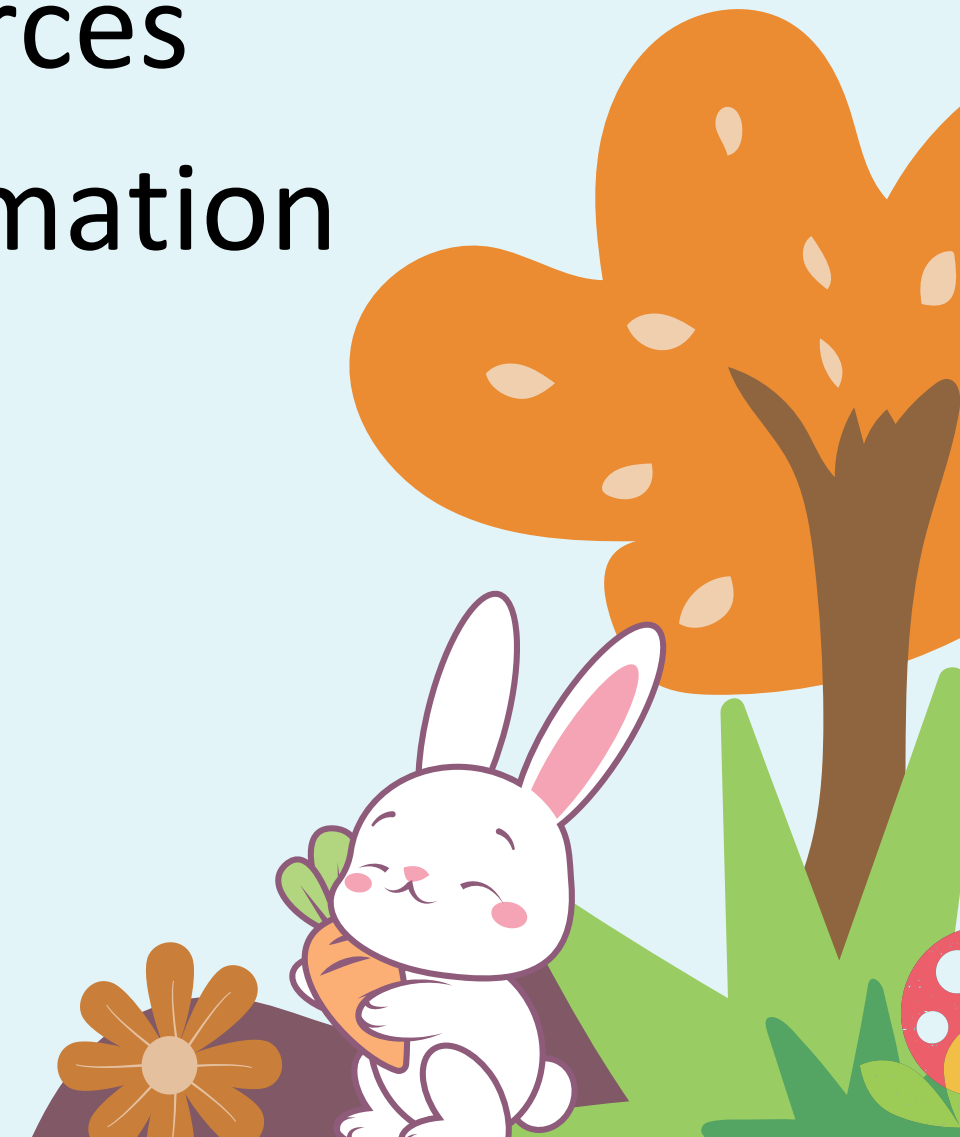

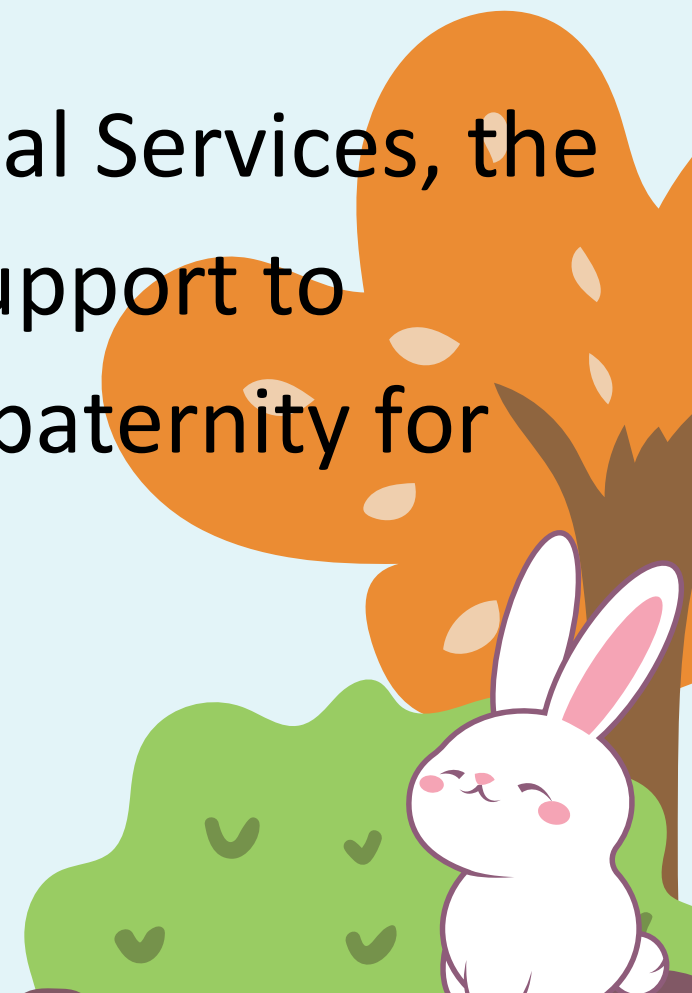
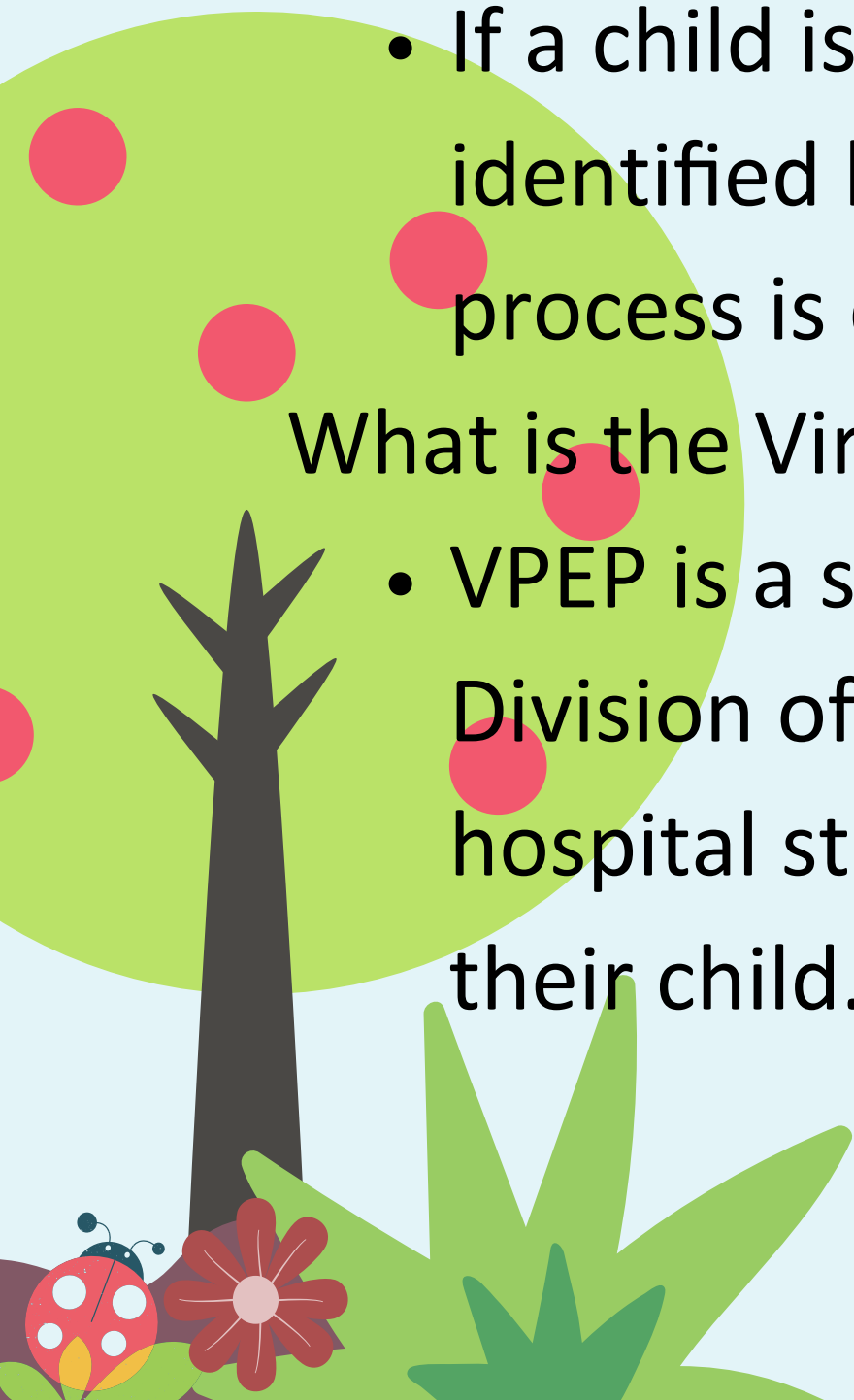
WHO WE ARE AND WHAT WE DO: VPEP DEFINED

What is “paternity establishment?”

- If a child is born to parents who are not married, the father must be legally identified before a father's name can be added to the child's birth certificate. This process is called establishing paternity.

What is the Virginia Paternity Establishment Program (VPEP)?

- VPEP is a statewide program under the Virginia Department of Social Services, the Division of Child Support Enforcement that provides training and support to hospital staff so they can help unwed parents voluntarily establish paternity for their child.



WHO WE ARE AND WHAT WE DO: VPEP IS IMPORTANT

Why is VPEP Important to Parents?

- VPEP works to promote voluntary paternity establishment which engages families for success and encourages healthy relationships between parents and children
- VPEP connects families with necessary resources to ensure their children have the best possible beginning
- VPEP educates Virginia's families and communities about the importance and benefits of paternity establishment through partnerships with local agencies and hospitals
- Directly related to TANF money received

WHO WE ARE AND WHAT WE DO: VPEP IS IMPORTANT

Why is VPEP Important to Hospitals and Natural Birthing Centers?

- Per the Commonwealth of Virginia Statute, 673.2A1914, “Each public and private birthing hospital in the Commonwealth shall provide unwed parents the opportunity to legally establish the paternity of a child prior to the child’s discharge from the hospital following birth, by means of a voluntary acknowledgement of paternity signed by the mother and the father, under oath.”
- In accordance with Virginia law, VPEP offers training to all professionals who assist parents with paternity establishment (such as Birth Registrars)
- Monetary incentives are provided to all Midwives (\$20 for every AOP completed)
- VPEP’s training and outreach efforts support families in your community

WHO WE ARE AND WHAT WE DO: THE VPEP TEAM

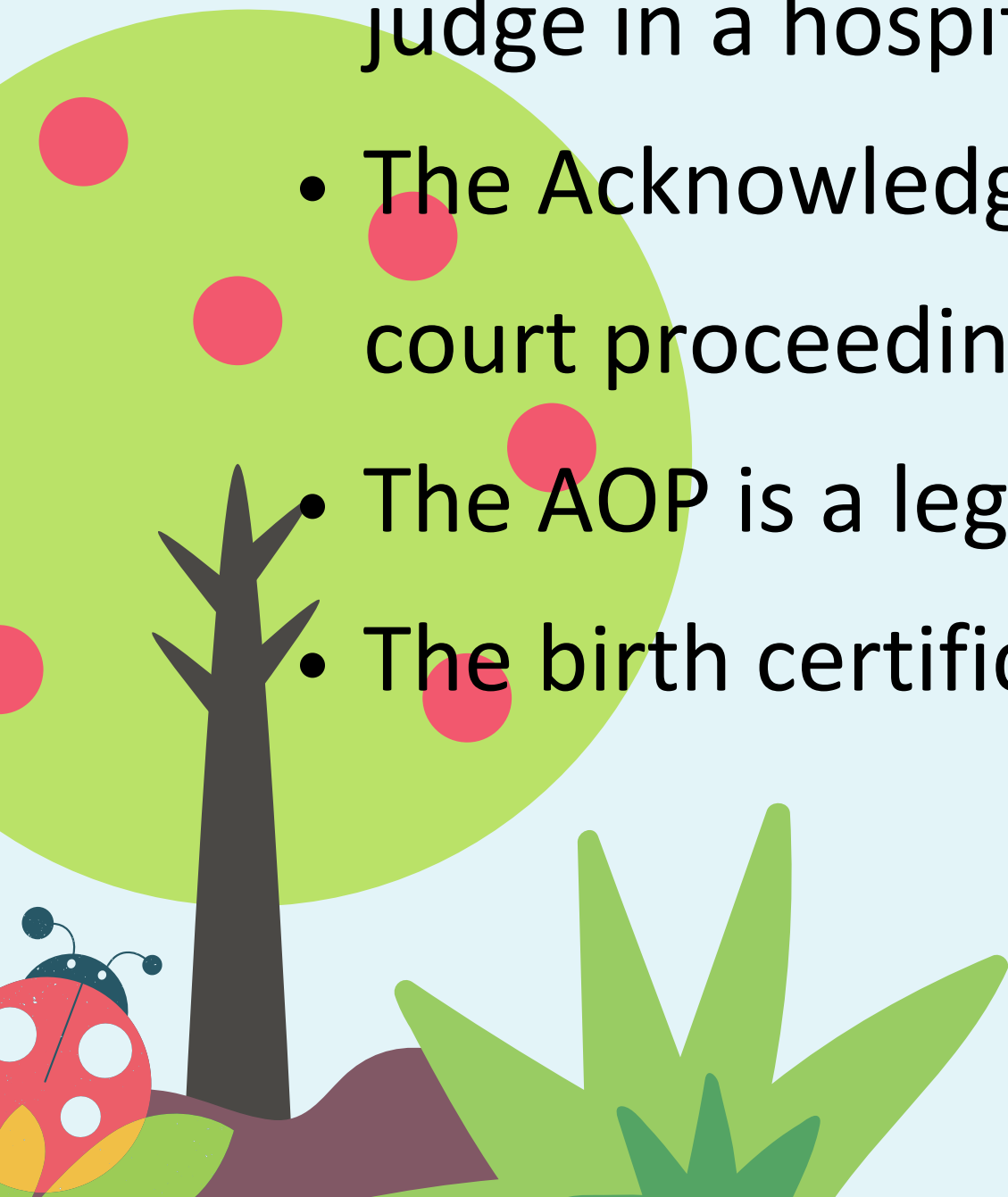
VPEP has a team of training, outreach and educational specialists located throughout Virginia. There is a specialist located in each of the following territories:

- Northern Virginia
- Eastern Virginia
- Western Virginia
- Central (Richmond) Virginia
- Our home office is centrally located in Richmond, Virginia



POWER OF THE JUDGE

- The Commonwealth of Virginia gives the birth registrar the power of a judge in a hospital setting to add the birth certificate
- The Acknowledgement of Paternity (AOP) form takes the place of a legal court proceeding
- The AOP is a legal document
- The birth certificate is a person's first legal document



REASONS FOR MIDWIVES TO ADD DADS TO THE BIRTH CERTIFICATE AT THEIR FACILITY

- Receive \$20 per AOP
- Helps to ensure that children are entitled to receive father's military benefits
- Help to ensure that children can access social security benefits if father passes
- Help to ensure that children have access to paternal medical history
- Helping to build a legal connection between the father and the child

REASONS FOR MIDWIVES TO ADD DADS TO THE BIRTH CERTIFICATE AT THEIR FACILITY

- Builds a partnership between the facility and the VPEP program
- Quarterly incentives
- It is free for parents to complete AOP at the facility
- Midwives and doulas will receive training on how to complete the AOP
- Can help with bringing in more parents to give birth to their children at the facility



HANDS ON TRAINING: THE PROCESS

In order to effectively do your job and correctly process AOPs, you must be organized. You can do that by:

- Marking “S” or “M” at the top of the intake forms so that you know to process all single mother paperwork first
- Start with unmarried parents as soon as possible. The best way to do this is to meet with unmarried parents at the beginning of the day to determine when the father will be available
- Keep a running log of daily patients and add legible notes for the person on the next shift to understand; keep a file by room number or patient name by a designated source

HANDS ON TRAINING: THE PROCESS AND YOUR NOTARY

In order to effectively do your job and correctly process AOPs, you must be organized. You can do that by starting with unmarried parents as soon as possible. The best way to do this is to meet with unmarried parents at the beginning of the day to determine when the father will be available.

It is your responsibility to keep your notary certification current. You must also:

- Notarize the form
- Include the business address
- Include your commission date (which expires annually in the month of your birthday)
- Make sure your commission # and notary stamp are valid and legible
- Stamp or seal must be reproducible

It is also important to note that if you have renewed your notary, you should call the Office of Vital Records immediately to ask them to update your renewal on the VVEST system so that AOPs you notarized are not rejected.

HANDS ON TRAINING: REJECTIONS

- Once VPEP or OVR rejects an AOP, it is returned to the birthing facility stating the rejection reason.
- Please note OVR will not contact you regarding an error. They will only contact the parent by mail.
- Once you have made contact with the parent and have corrected the AOP, a corrected copy must be forwarded to VPEP and the original is sent to OVR.

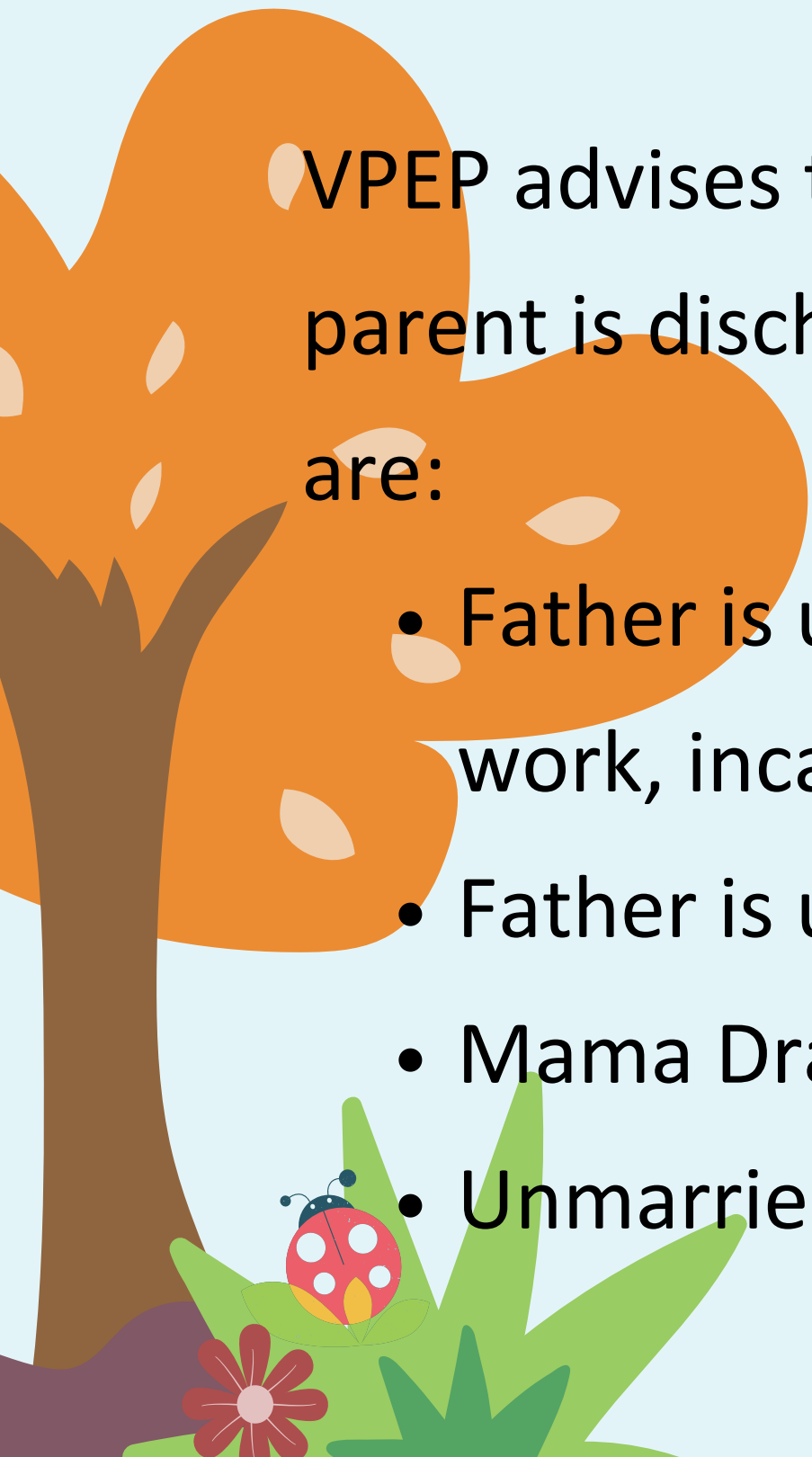
Common Rejection Reasons:

- Missing a signature
- Notary date error (i.e., sworn by date or today's date)
- The mother is married (as determined by OVR after submission)

HANDS ON TRAINING: INVITE PARENTS TO RETURN: “FOLLOW UP PROCESS”

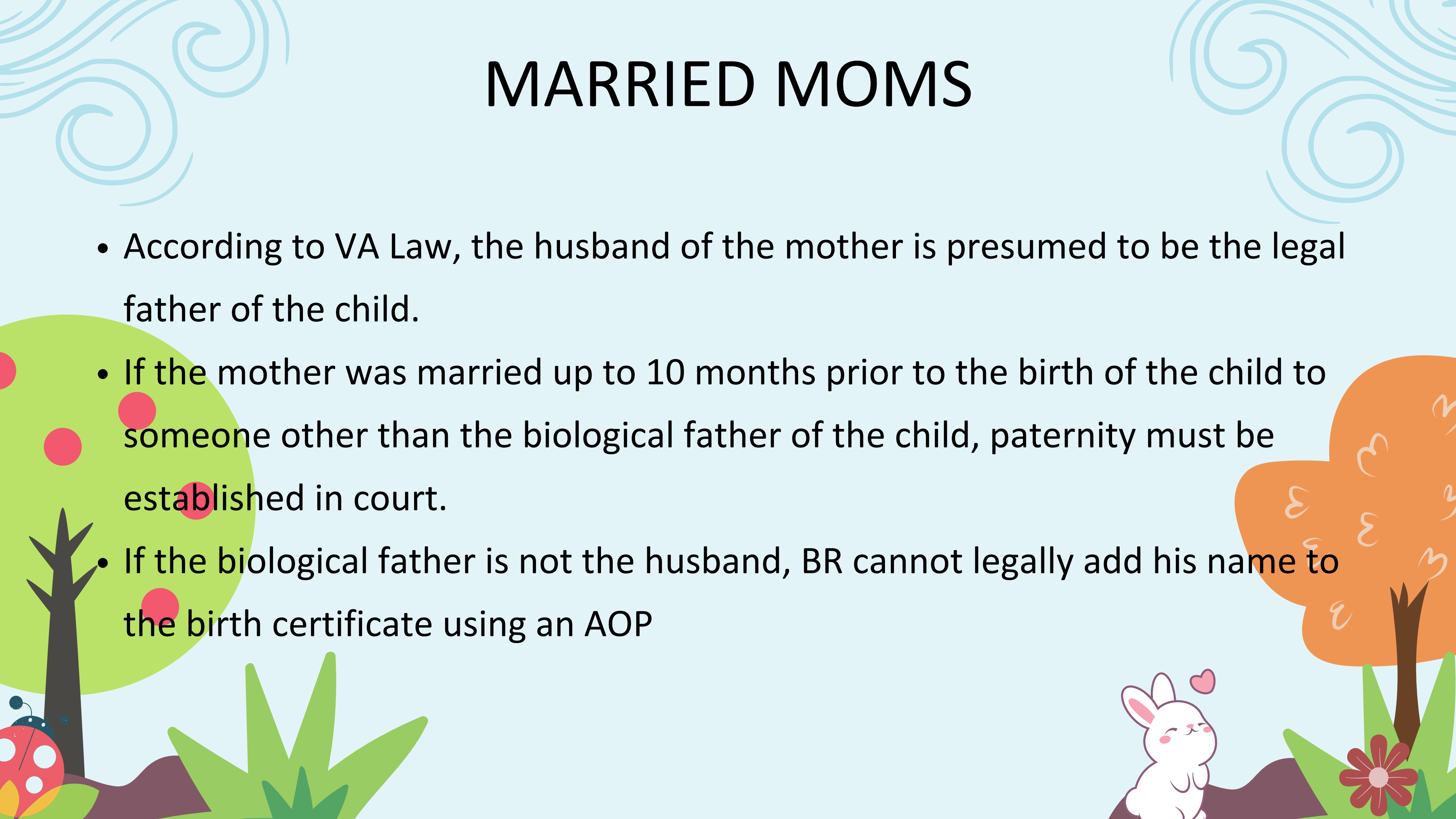
VPEP advises that a birth registrar use the “follow up” process when an unmarried parent is discharged without completing the AOP. Examples of these instances are:

- Father is unavailable while mother is in hospital (military, out of country, at work, incarcerated)
- Father is unsure if he is the father (DNA Testing)
- Mama Drama (mom and baby’s father are fighting)
- Unmarried parents change their mind



MARRIED MOMS

- According to VA Law, the husband of the mother is presumed to be the legal father of the child.
- If the mother was married up to 10 months prior to the birth of the child to someone other than the biological father of the child, paternity must be established in court.
- If the biological father is not the husband, BR cannot legally add his name to the birth certificate using an AOP

Did you have a baby and are currently married, separated or recently divorced from someone other than the biological father?

- According to Virginia law, the husband of the mother is presumed to be the legal father of the child. If the mother is married or was married up to 10 months prior to the birth of the child to someone other than the biological father of the child, paternity must be established in court.
- If the biological father is not the husband, the birth registrar will be unable to add his name to the certificate using the AOP.
- The mother and her husband's name will appear on the child's birth certificate unless the mother refuses to give the name of husband to the registrar.
- You must contact your local Circuit Court and/or Juvenile & Domestic Relations Court to legally establish paternity for the biological father.

WHAT IS PATERNITY? Paternity means fatherhood. Establishing paternity is the process of determining a legal father of the child.

PATERNITY AFFECTS EVERY CHILD THAT IS BORN TO UNMARRIED PARENTS:

- If paternity is established there is a legal relationship between father and child, and child is allowed all the same benefits/rights as being born to a married couple.
- Research shows that when fathers are involved with their children they have:
 - Less criminal involvement
 - Less behavioral problems and acting out
 - Less drug usage
 - Less teenage pregnancy
 - Improved school success and a greater likelihood to graduate from high school

Did you know?

- In the Commonwealth of Virginia, if parents are not legally married at the time of birth, the father's name will not appear on the child's birth certificate unless paternity is established.
- If parents are not legally married at the time of birth, they can establish paternity by signing an Acknowledgement of Paternity (AOP) form as part of the birth registration process or at a later time.
- In order to be recognized as the child's legal father and have rights, the biological father must establish paternity.
- Being the legal father of your child does not mean that you will be required to pay child support, have custody or even visitation. These are separate issues and require court determinations.

Q: What is paternity establishment?

A: Paternity means legal fatherhood. Establishing paternity is the process of determining a legal father of the child. Unmarried parents can establish paternity at the hospital after the birth of their child as part of the birth registration process.

Establish Paternity By:

- AOP: Signing a voluntary AOP form
- DNA: Securing a genetic test through Child Support Enforcement or a certified laboratory
- Court: Contacting the local Juvenile Domestic Relations Court

Q: How do I establish paternity through a voluntary process?

A: It's simple! If you have an unmarried partner, you can establish paternity by signing an Acknowledgement of Paternity (AOP) form at the hospital after your child's birth. If you are unable to complete the AOP at the time of birth, you may return to the hospital at a later date or you may contact the Division of Child Support Enforcement (DCSE), the Division of Child Support Enforcement (DCSE), or the Virginia Department of Health (VDH) to complete an AOP. Q: How much does it cost?

A: It's free if you complete the AOP at the hospital after your child's birth. If you are unable to complete the AOP at the time of birth, you may return to the hospital at a later date or you may contact the Division of Child Support Enforcement (DCSE), the Division of Child Support Enforcement (DCSE), or the Virginia Department of Health (VDH) to complete an AOP. You may also mail your completed AOP to the Division of Child Support Enforcement (DCSE), the Division of Child Support Enforcement (DCSE), or the Virginia Department of Health (VDH) to complete an AOP.

Q: What are my responsibilities if I establish paternity?

A: Each parent must understand the Rights and Responsibilities associated with establishing paternity. This information is specified on the AOP form. Please review the Rights and Responsibilities carefully before signing the document.

Q: What if one of the parents change their mind after signing the form?

A: Parents should think carefully before establishing paternity. If you do change your mind, you have 60 days from the last notarized signature date to rescind the AOP. Either parent may cancel or "rescind" the AOP by completing a rescission form at the Division of Vital Records or a local Department of Health.

Q: How does establishing paternity help my child?

The greatest statistical indicator of whether or not an unmarried dad will be involved in his child's life is whether or not he establishes paternity. Give your child the advantage of having a father right from the start!

- Self Esteem: Children respond better to love and support from both parents. They gain a sense of belonging and benefit from knowing that both of their parents care for them.
- Family Identity: When children know they are part of a family, they are likely to be more involved in their family's life and more likely to be successful in school and in life.
- Shared Parenting: Parenting is the responsibility of both the father and the mother. Studies show that this results in a decrease in high risk behavior by the child. Finally, more resources are available when both parents share the responsibility of raising their child.
- Health History: A child is more likely to have a complete health history if paternity is established. Knowing the father's medical history is important for children and their physicians. Additionally, a health history is critically important if there are conditions that may prevent any medical health problems (disease, genetic traits, and donor information for transplant).
- Important Rights: When paternity is established, the child has the same rights as a child born to a married couple. When a father does so, he permanently establishes a legal father assumes benefits for the child (medical or insurance benefits, inheritance, social security disability or veterans benefits).

If you are not sure who the father is, you should not complete the AOP form. You may also consider contacting an attorney of your choice or contact your local Juvenile Domestic and Relations court (JDRC) for more information about your situation.

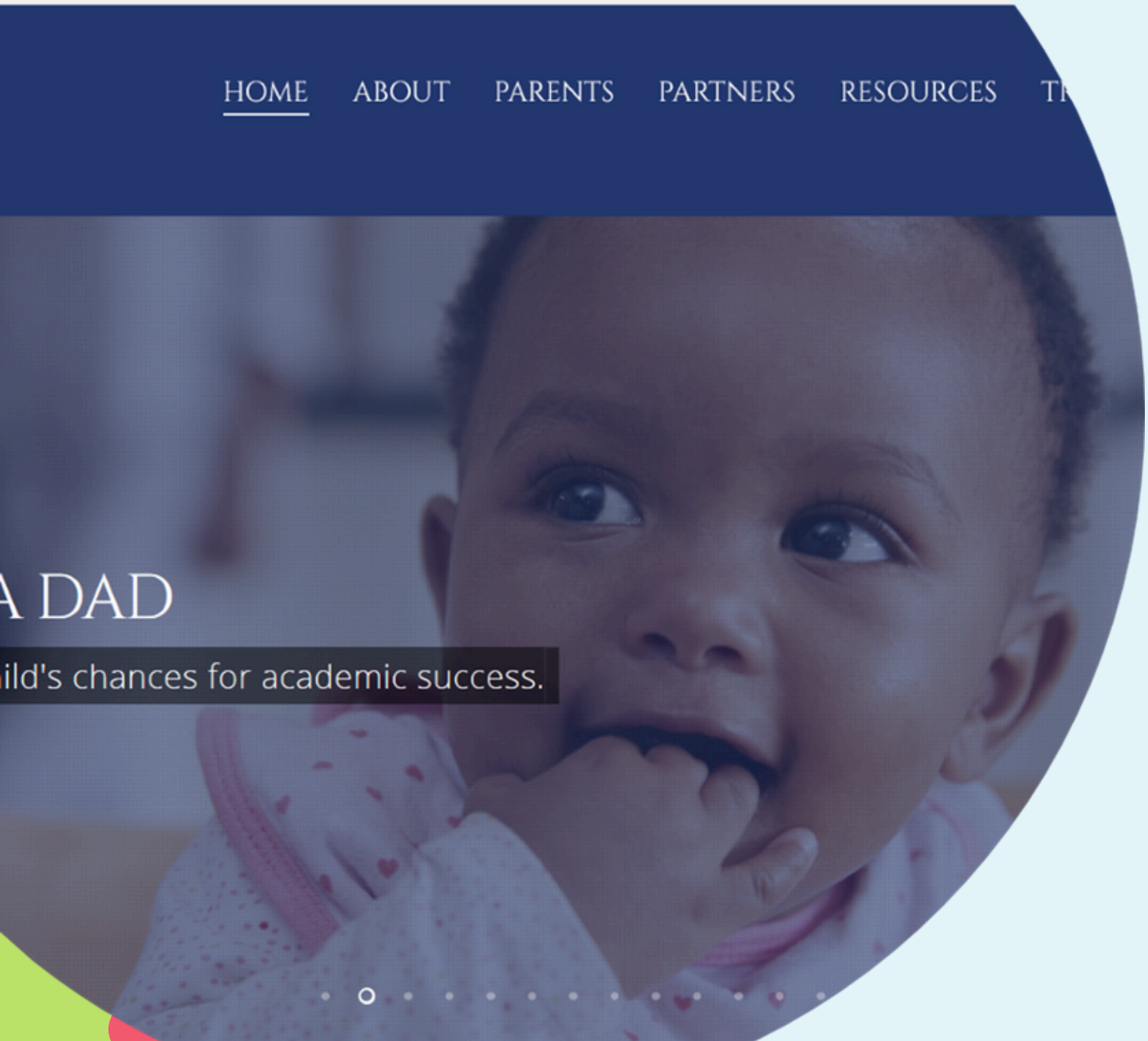

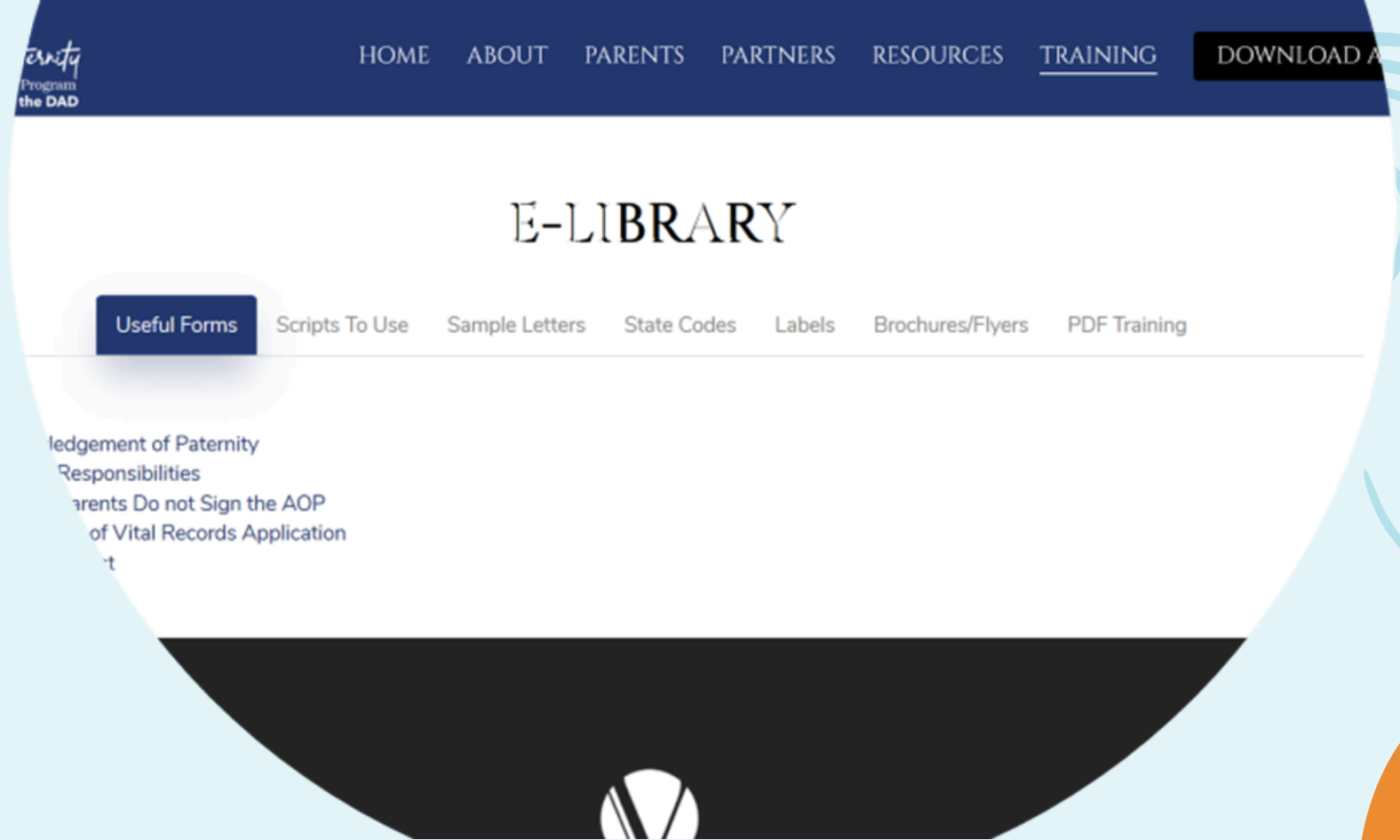

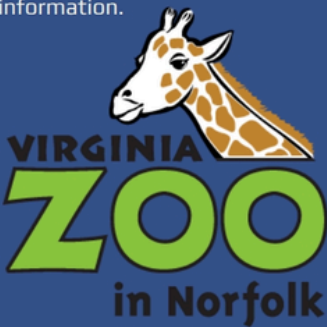


COMMUNITY SPOTLIGHT

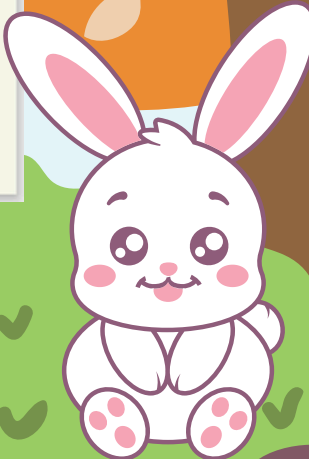

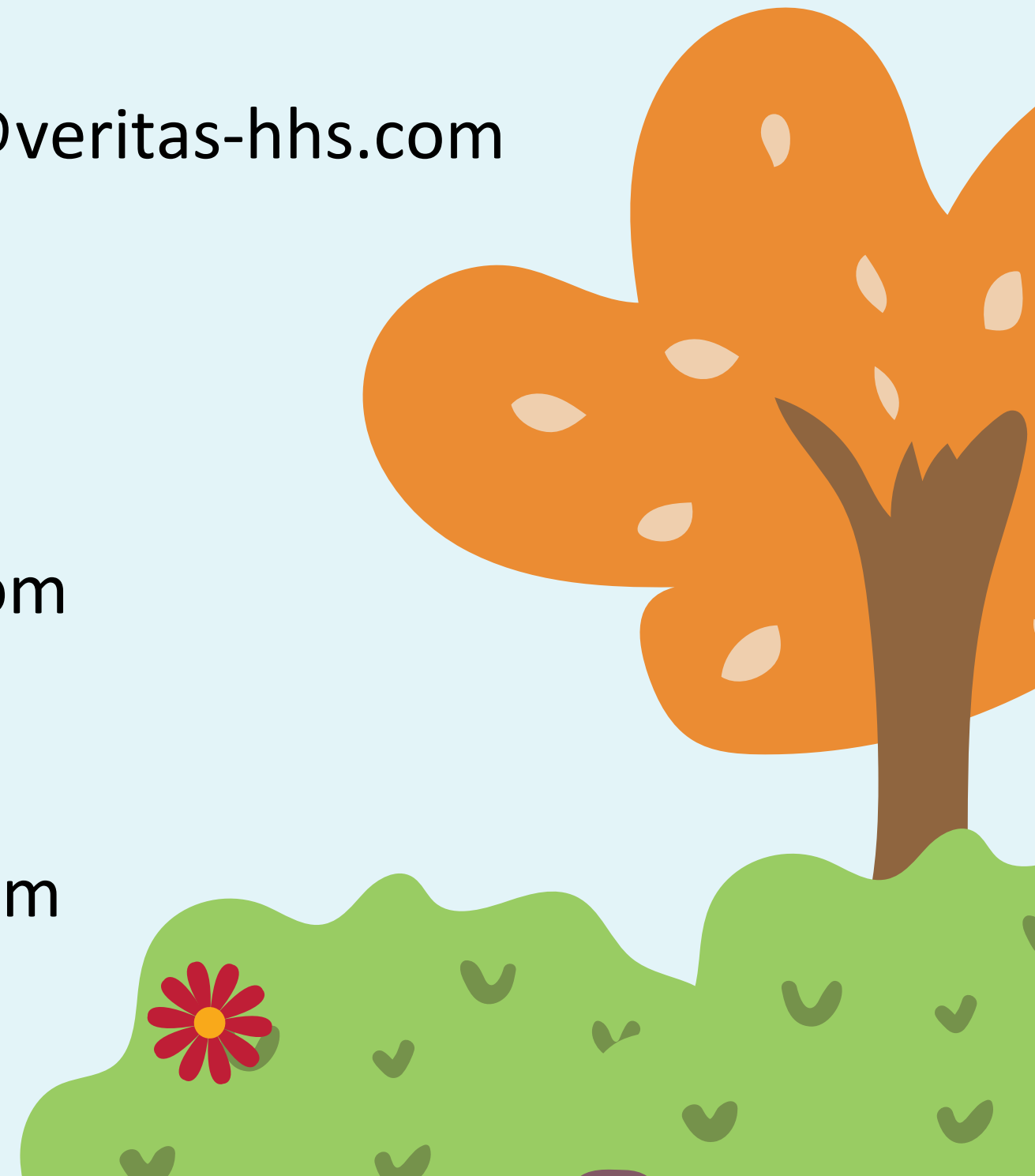

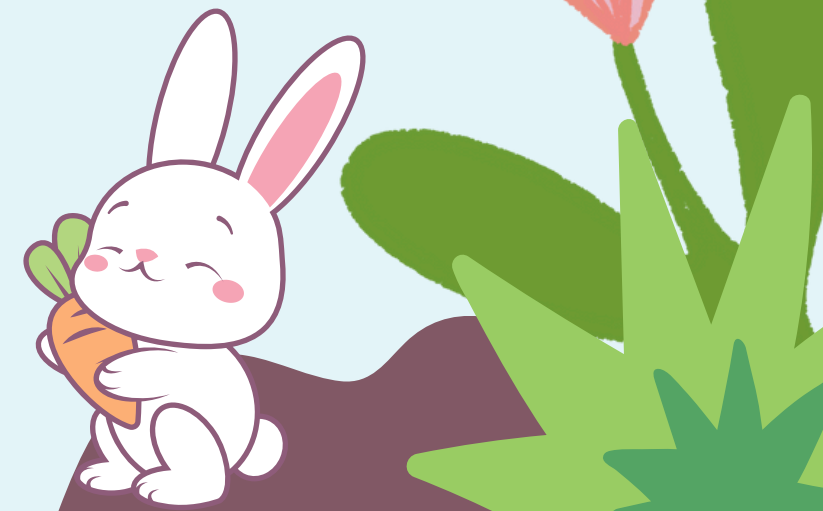
